Dear Parent,

You are requested to note the following information in related to the school Conveyance.

- 1. You are requested to fill the Conveyance form or inform at school transport office with complete details of your ward to avail transport facility.
- 2. Vehicle will be provided according to the availability of seats on the route. No special request will be entertained for BUS or Small Vehicle.
- 3. Total II months transport fee will be charged in an academic session.
- 4. All students from class I to XII (specially class X, XI & XII)availing transport facility have to pay fee for 11 months till the academic session ends.
- 5. Any new route will be considered only after 4-5 students from that particular area and fee for the new route will be decided after mutual discussion between PARENTS and the Bus VENDOR.
- 6. Fee for pick up points or area not mentioned in the fee chart will be charged according to distance and no. of students from that pick up points.
- 7. No student will leave conveyance facility in MID-SESSION.
- 8. Parent have to deposit transport fee in advance as per the following schedule:-

For Class I to IX

- 1st Installment (3 months) on 6th May 2024
- 2nd Installment (3 months) on 1st July 2024
- 3rd Installment (3 months) on 1st October 2024
- 4th Installment (2 months) on 1st January 2025

For Class X to XII

- 1st Installment (4 months) on 6th May 2024
- 2nd Installment (4 months) on 1st August 2024
- 3rd Installment (3 months) on 1st November 2024
- ➤ Transport fee can be deposited either at the school transport office (main gate) or Online to Mr. Naresh-9694258655 and Mr. Manjeet 8955682776. Please collect the receipt for the fee paid.
- We request parents not to pay the fee to drivers or any other person.
- > The Bus Vendor is not responsible for the fee paid without collecting receipt or to drivers or any other person.
- > The Bus Vendor has the right to withdraw transport service if the fee is not paid on time.
- > Fee once paid will not be refunded.

- > Students are advised to be ready well in time at pickup point at the given pickup time. The driver is not responsible if the student is not present on pick up point as School management will not allow latecomers.
- > The student will not be allowed to use the bus service if he/she misbehaves with the driver or other students.
- ➤ Vehicles will not wait after 10 min of school dispersal time to maintain schedule. Students who will not report to their respective vehicles on time will be left in school.
